1 Introduction

This document provides a short report for the activities carried out by eIFL during the year 2003, in terms of workshops, participation in conferences, addition of new participating countries, and signature of new agreements with publishers, its own internal organization and development.

2 Organization and development within eIFL

Website

Since April 16 2003, the eIFL.net Web site has been fully restructured and it has taken on a completely new look and feel. Its content has been revised and updated and we will continue to further expand and enhance it in the coming weeks. The portal aims to be a dynamic information tool where news, events, documents and any eIFL.net related material will be announced and made available to the eIFL community.

A real important framework is devoted to the news section. Newsflashes, offering continuously updated information not only on the eIFL related news, are published, and above all, a large section describing all the international news of interest for the entire eIFL community is provided.

Three new sections have been added on the eIFL web site. These are:

- Open Access Init. The Budapest Open Access Initiative promoted by the Open Society Institute and aimed at boosting the process of making research articles in all academic fields freely available on the Internet;
- Open source software OSS a section providing resources, material and useful links aimed to support eIFL library consortia and any other library or institution interested in OSS, to get familiar with the main aspects of Open Source Software's usage and implementation;
- Free Journals Linking to the Directory of Open Access Journals DOAJ, a newly established initiative currently offering information about 350 open access journals.

General Assembly

The 2003 eIFL coordinators general assembly has been organised in Pula, Sardinia, Italy from 18th to 22nd of October in the framework of the Science and Technology Park of Sardinia. The GA joined more than 70 people from 41 different countries and more than 20 publishers. Sardinian local authorities and Science and Technology park contributed 25,000 euro to the event.

Board

In January eIFL.net has become an independent foundation with a small office in Rome, Italy.In February, Frances Pinter completed the tasks as interim CEO to establish the foundation. The first Advisory Board meeting was held on the 27-28 March 2003 in Rome. The second and third Advisory Board meetings, chaired by Law Derek, took place respectively on 2-3 August in Berlin, on 22 October 2003 in Cagliary.

Logo

eIFL.net as a new independent organisation has produced a new leaflet and a logo.

These are available for the country coordinators from the members-only section on the current eIFL web site, under'Marketing'- 'Marketing templates'.

Partners

During the summer, meetings were hold with Goethe Institute, IFLA, ICOLC, FAO, INASP, Biomed Central and TIB, the German National Library of Science and Technology, on how to collaborate and how eIFL consortia could make the best use of the resources that are being offered by those intiatives.

6 New agreements with publishers

During this period, eIFL has signed several agreements in Science and Technology. These are listed in the table below. In particular, a column was added to show the number of titles that were added as a consequence.

Although eIFL did not sign any agreement with EBSCO, it facilitated the contracts for the next 3 years.

eIFL contacted Content Complete to advise 6 countries which originally expressed an interest in signing the contracts with Elsevier.

A trial access to Russian content databases was opened in March for the eIFL members interested in Russian language resources. This activity has been coordinated by NEICON Russian Consortium, headed by Alexander Kuznetsov. Russian databases are provided by Integrum-Tehno and Eastview, representing 24 and 6 databases respectively. These databases contain massmedia, reference books, social science journals and others. 273 libraries from 11 countries have taken part in the trail.

The eIFL project has produced a model contract and a model licence that will be used in connection with the deals negotiated by eIFL.net with an individual publisher.

The final eIFL model licenses are available both for publishers and for countries.
